State EMS Advisory Board

The last meeting of the Advisory Board was held two weeks ago. The opioid crisis was discussed. A legislative package has been created to address what's become a public health emergency. Replica was also discussed. Ten states needed to come on board with it in order for it to be initiated & VA is one of them. TN is the only other state that borders VA that's adopted it but WV is in the process. They're currently working on getting MD & NC added. Tuition funding for EMT was discussed. There's concern

about the process & how it'll be funded up front. The Attorney General's office made it mandatory to use the standard procurement process used elsewhere. Changes to the rules & regulations probably won't happen until sometime next year. The status of the Intermediate program was also discussed. New programs will be eliminated but current Intermediates will continue to maintain their certification as long as they don't lapse. There wasn't much feedback from the town hall meetings so it was decided to move forward.
